The unit's strategic objectives are embodied in accordance with the national policy to address internal displacement in the Republic of Yemen as follows:

- Protect civilians from involuntary displacement and prepare for any possible displacement.
- Protect and assist IDPs during displacement and support communities affected by displacement.
- Create appropriate conditions for safe, voluntary and durable solutions to displacement.

The Vision

Professionalism in dealing with displacement and managing displacement camps in accordance with national and international standards.

Mission

An integrated and effective response to displacement in Yemen that emphasizes the rights of IDPs and the responsibilities of the authorities towards them based on transparency, accountability and confidentiality to ensure the provision of high-quality services.



Availability of all information about regulations and statistics on displacement, camps, IDPs, humanitarian aid of all kinds and forms, intervening organizations, and facilitating access to information.

The Executive Unit is actively committed to placing all its leaders and employees at all levels in accountability to society Ensure the quality of the response and provide relevant results, acknowledge any failures or errors that occur while doing so and take full responsibility.

Confidentiality of personal data

Confidentiality of personal data: The Executive Unit ensures that the personal data of the displaced that has been collected by the unit is kept confidential, and that it is not published or enabled by any party to access it except with the consent of the IDPs.

It is a set of characteristics and specifications that characterize the services provided by the executive unit to the displaced, and that meet the expressed and implicit desires and requirements of stakeholders in the appropriate time and form.



Introduction

The Executive Unit for the Management of IDPs Camps in Ma'rib Governorate worked through the annual report for the year 2021 AD, which covers all humanitarian activities and efforts done by the Executive Unit in all humanitarian and relief sectors in the governorate. The unit faced many challenges and great pressures in addressing the issues of internal displacement and forced displacement.

Especially with the exceptional circumstances that the governorate is experiencing, with very sensitive and fragile services and infrastructure, and the accompanying large and unprecedented waves and flows of displacement, which led to great pressure on the meager basic services. The unit was able to reach all the displaced people in the governorate, arrange their conditions, and conduct surveys and assessments for all needs communicate with all humanitarian partners, including local and international organizations, and providing them with all information support, arrangement and facilities for urgent and safe access to all affected communities and the sites and IDPs gatherings. The unit contributed to introducing the humanitarian situation through meetings, reports, humanitarian appeals and emergency messages to humanitarian and relief agencies, clarifying the humanitarian file, needs and challenges in the audio-visual media, and mobilizing all efforts to provide life-saving humanitarian services

The great challenges that Marib Governorate faced and the constantly violations caused by the terrorist Houthi militia and the accompanying displacement have made us all on the top of humanitarian responsibility.

We thank all humanitarian partners for providing humanitarian projects and assistance that helped alleviate the suffering and tragedy of the displaced. However, in the current year 2022 AD, we must as a whole redouble efforts to cover the gap in the basic needs of the displaced families in Ma'rib Governorate..



Manager's Speech





As we review 2021 Performance Report, we would like to extend our thanks and appreciation to all those who contributed and helped in the success of our action. Official and civil bodies and local and international organizations, and thanks are extended to all workers in the Executive Unit and sectors, sites and camps management, who made all their efforts and time for the sake of success of humanitarian task entrusted to all of us. In this new year, 2022, we hope that all local and international humanitarian partners, to provide a lot of humanitarian support, redouble efforts, and keep pace with everything that would distinguish and advance our humanitarian work, administratively and on the ground, to help and save the lives of thousands of displaced families.








- Work to make health services available and easy to access from the camps and take care of the health of the mother and child.

- Ignoring the request for the adoption of Ma'rib Governorate as a financially and administratively independent humanitarian center to estimate the level of the large displacement in the governorate
- Weak participation of the competent official offices in planning humanitarian projects in various fields of importance and directing donor funding to projects of the highest priority
 - The weak response in the sectors of food security, shelter, NFI, health, education and protection by international and local partners, compared to the size of displacement and need in the governorate
- Procrastination by UN and international organizations in approving the correct numbers for the population in the governorate issued by the official offices in the governorate (Statistical Office Executive Unit Office -Planning Office) and receive information and reports from non-official bodies.
- Humanitarian agencies' adoption of incorrect indicators of the severity of needs in several sectors, including health, which surprised us by placing Marib Governorate in the second degree, and Marib is supposed to be in the extreme degree of need This has led to the governorate being at the bottom of the humanitarian response lists, which puts OCHA, the humanitarian coordinator, and the UN agencies under suspicion and accountability
- Most of the partner international organizations do not have major branches in the governorate to adopt integrated projects according to needs, which made their interventions limited and meager.




- There is no operational budget for the executive unit office in the governorate.
- There is no reserve stock for emergency interventions subject to the executive unit and the cluster in the Ma'rib governorate to face the continuous and intense waves of displacement and consumer needs.
 - There are no state-owned lands to house the newly displaced, because the governorate receives displaced people on a continuous basis, and there are camps that have been established in government facilities, and they need urgent treatment to provide alternative places.




Recommendations





- The necessity of approving Marib as a humanitarian center that is financially and administratively independent, has all powers and is subject to attention and activation.
- The significance of UN and international organizations carrying out their humanitarian responsibilities, and opening offices in the governorate for non-existent organizations, whether from UN or other international organizations
- The significance of the presence of blocks that did not exist in the governorate, especially the protection block, and the activation of existing sub-blocks
- We hope the government will mobilize efforts to provide a reserve stock for emergency interventions subject to the Executive Unit to confront the ongoing waves of displacement.
- We call upon the International Committee of the Red Cross to enhance its active presence and raise the level of its interventions in Marib Governorate
- Participation of the specialized offices in planning humanitarian projects in various fields of importance and directing donor funding to highest priority projects.





- Approving an operational budget for the office of Executive Unit in Marib Governorate.
- Finding an adequate mechanism to address the situation of displaced families in service facilities and working to find alternative sites.
- We hope that the government finds lands to build a residential city to accommodate the needy displaced people, since the governorate is receiving continuous displacement.


